


TWDB Grant Coordination

Flood Mitigation Assistance Grant

Federal funding for projects that reduce or eliminate the risk of flood damage to structures insured under the NFIP

Flood Infrastructure Fund

Support the local match for federal award

Support already-vetted flood mitigation projects


Flood Mitigation Assistance Grant (FMA) Swift Grants

Requires Federal Flood Disaster Declaration. Federal funding for projects in communities under federal disaster declaration.

Purpose: Assist Texas communities by providing federal and state funds for cost-effective flood mitigation measures to reduce or eliminate the long-term risk of flood damage.


State Flood Plan

- First-ever Texas State Flood Plan submitted to legislature Sep 2024
- 5yr cycle, but first cycle abbreviated 3-4yrs
- 15 Regional Flood Planning Groups (RFPGs)
- Over \$54B in projected costs
- Identified over 4,500 projects
 - Over 3,000 of those are studies
- Over a dozen policy recommendations



Flood Infrastructure Fund (FIF) Program

- State funded Loan and Grant
- Prior round \$770M, ~140 projects and >90% funds committed
- New appropriation \$625M
 - Offering \$375M during FY24-25 FIF Cycle
- New Application Cycle closed April 15, 2024, but Year-Round submittals available
- Flood Management Strategies (FMS) Board Approval Sep 2024, Final Apps due Nov 2024
- Flood Management Evaluations (FME) And Flood Mitigation Projects (FMP) under review



Flood Infrastructure Fund

Project Eligibility and Types


Project Eligibility

- Part of state flood plan
- Cost effective (construction)

Project Types- Must be RANKED in Regional and State Flood plan

- 1) FME- Drainage Studies, planning studies
- 2) FMP- Acquisition, Design, and Construction projects
- 3) FMS- Flood Warning, Education /Outreach, Emergency Action Plans


*All project types allows for Federal Award Matching



Application Cycle

- **Bi-Annual Program**
- **Two Step Application Process**
 - **Abridge Application-**
 - ❖ Abridge applications are reviewed for eligibility
 - ❖ Priority Ranking (30-day comment period)
 - ❖ Approved by the TWDB Board
 - **Invited Applications**
 - ❖ Approximately two months to submit
 - ❖ All approved application requires TWDB Board Commitment approval
 - ❖ **Closing- All agreement and/or Loan documents are executed**





Four Corners of FMA




Provide federal funding to help communities pay for cost-effective measures to reduce or eliminate the long-term risk of flood damage

Increase climate adaptation and resiliency in the face of more frequent flooding of socially vulnerable communities


The Infrastructure Investment and Jobs Act



FMA Eligibility Requirements

Eligible Sub-Applicants

- Local jurisdictions or political subdivisions
- Active participants in the NFIP
- Have a FEMA approved Hazard Mitigation Plan

Eligible Projects

- Reduce or eliminate risk of damage caused by flooding for **NFIP insured structures**
- Cost Effective (using FEMAs approved methodology)
- Align with local hazard mitigation plan
- Meet all environmental regulations

Individual Flood Mitigation Projects

Elevate National Flood Insurance Program (NFIP) homes to mitigate future flood risks

Individual Flood Mitigation Projects

Acquire National Flood Insurance Program (NFIP) structures and maintain open space

Capability and Capacity Building (C&CB) Activities

Cultivate partnerships to plan for future whole-community flood mitigation initiatives

Localized Flood Risk Reduction Projects

Create a sustainable living shoreline





Geospatial Files

Capability and Capacity Building Activities-Project Scoping and Additional Capability and Capacity Building Activities priorities, and Localized Flood Risk Reduction Project subapplications must demonstrate that the proposed project benefits NFIP insured properties by submitting a map and associated geospatial file(s) (e.g., shapefile, Keyhole Markup Language(KML/KMZ), geodatabase, list of census tracts, or other geo-enabled documents)

Benefit Cost Analysis (BCA)



FEMA's BCA Toolkit 6.0

Modeled Damages Data Needs

- H&H studies pre & post mitigation
- Building/structure data- Lowest floor elevation, square footage, etc.

Historical Damages

- At least 3 events within 30 years and \$ value lost (or 1+ events each with a known Recurrence Interval)



Streamlined BCA Methodology


Projects <\$1 Million- BCA Memo

Using Pre-Calculated Benefits:

- \$360K for Demolitions in the SFHA or designated RL/SRL
- \$228K for Elevations in the SFHA
- Substantially Damaged Structures





 - FEMA-approved local or tribal hazard mitigation plan
- **Project Eligibility**
 - NFIP Insured Structures
 - Cost Effective (construction)
- **Project Types**
 - Individual Flood Mitigation
 - ❖ Acquisition/Demolition
 - ❖ Elevations
 - ❖ Mitigation Reconstruction
 - Phased
 - ❖ Communities having received IA & PA
 - ❖ Highest # of claims


FMA Swift Grants

NOFO FY 23, ~\$200M nationally

- Based on pre-set metrics, each state may receive between \$5 to \$40M in funding per disaster
- DR-4781-TX (Apr 26-Jun 5, 2024) - First federal flood disaster in TX since Hurricane Laura (2020)
 - FEMA allocated TX \$40M for FY23
 - Statewide application due to FEMA Nov 18, 2024



FEMA-4798-DR, Texas Disaster Declaration as of 07/13/2024



NOFO FY24, ~\$300M nationally

- Based on pre-set metrics, each state may receive between \$5 to \$40M in funding per disaster
- DR-4798-TX (July 5-9, 2024) – Hurricane Beryl
 - FEMA allocated TX \$40M for FY 24
 - Statewide application due to FEMA February 10, 2025

Additional Funding at TWDB

State Water Implementation Fund for Texas (SWIFT)

- Helps communities develop cost effective water supplies by providing low-interest loans, extended repayment terms, deferral of loan repayments, and incremental repurchase terms.

State Revolving Fund (SRF)

- Drinking Water SRF: Projects that facilitate compliance with Drink Water Standards
- Clean Water SRF: Projects that facilitate compliance with the federal Clean Water Act

Texas Water Development Fund (DFund)

- A streamlined state loan program that provides financing for various types of infrastructure projects. This program enables TWDB to fund projects with multiple purposes (e.g., water and wastewater) in one loan.

Agricultural Water Conservation

- Provides grant and loan programs to provide financial assistance for agricultural water conservation projects in Texas.
